Thank you for each of your individual and organizational contributions into engaging with the encampment legislation that has been proposed by Councilmember O'Brien, Herbold, Johnson and Sawant. After many of us have had separate conversations about this legislation and have identified shared principles, it would be extremely helpful for us to meet together to find consensus on language to move this process forward. There definitely is a successful plan for legislating this issue and I am confident that will be done with all of us participating together.

As you aware, this work is somewhat urgent, and our goal will be to schedule a meeting on Monday, September 26, or Tuesday, September 27. My colleague LaKecia Farmer will be supporting me in identifying a time and place for this meeting.

And lastly, Councilmembers, I am sure you are all aware that because of Council rules, this meeting can only include four Councilmembers. We have confirmed interest in attending this meeting from Councilmember O'Brien, Johnson, Herbold, and Bagshaw. Depending on when the meeting time is confirmed, there might be opportunity for another Councilmembers to join us. Of course, any Council staff from the offices contacted are invited to join us.
