We express a vote of no confidence in Boss Man.

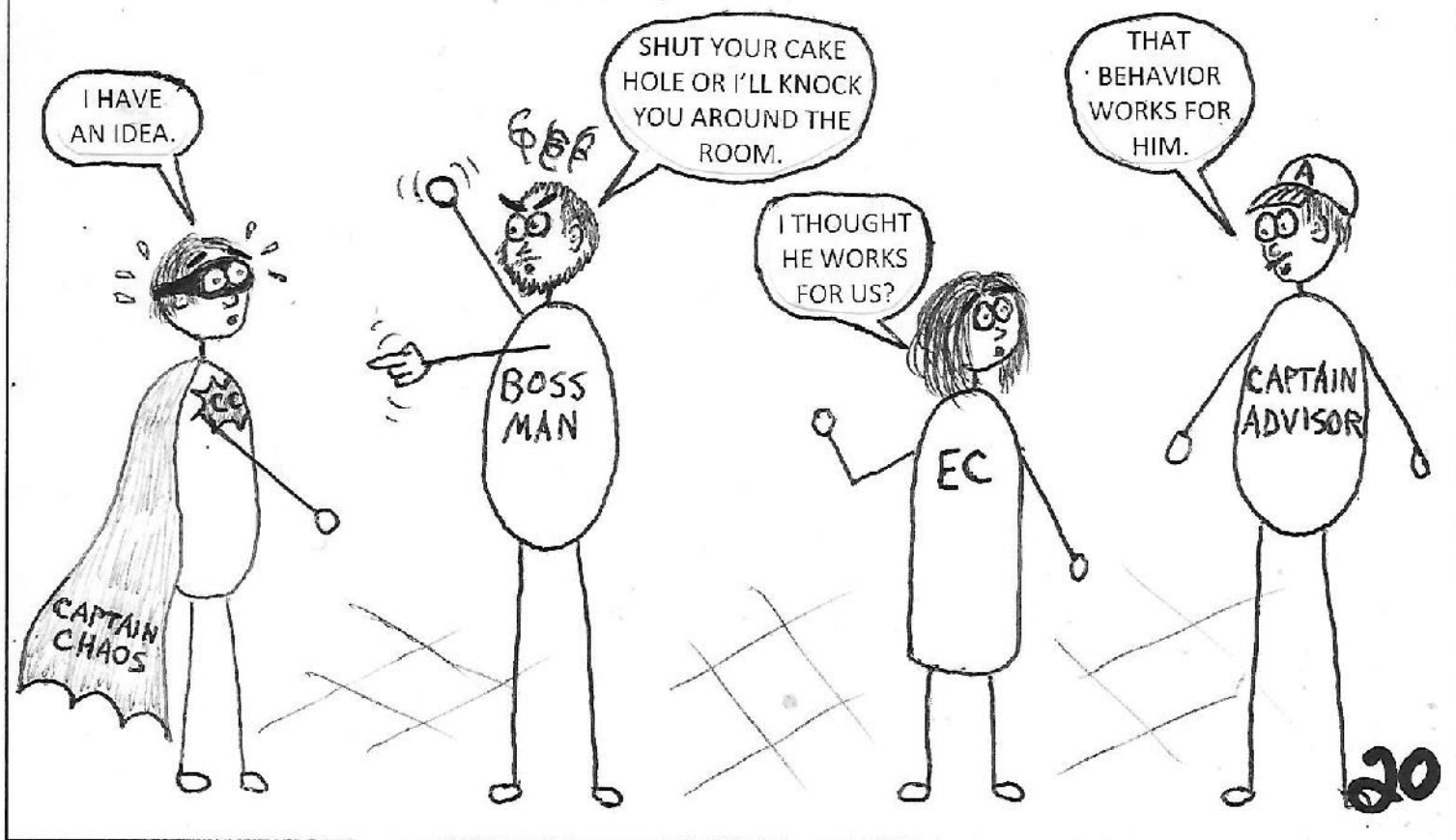

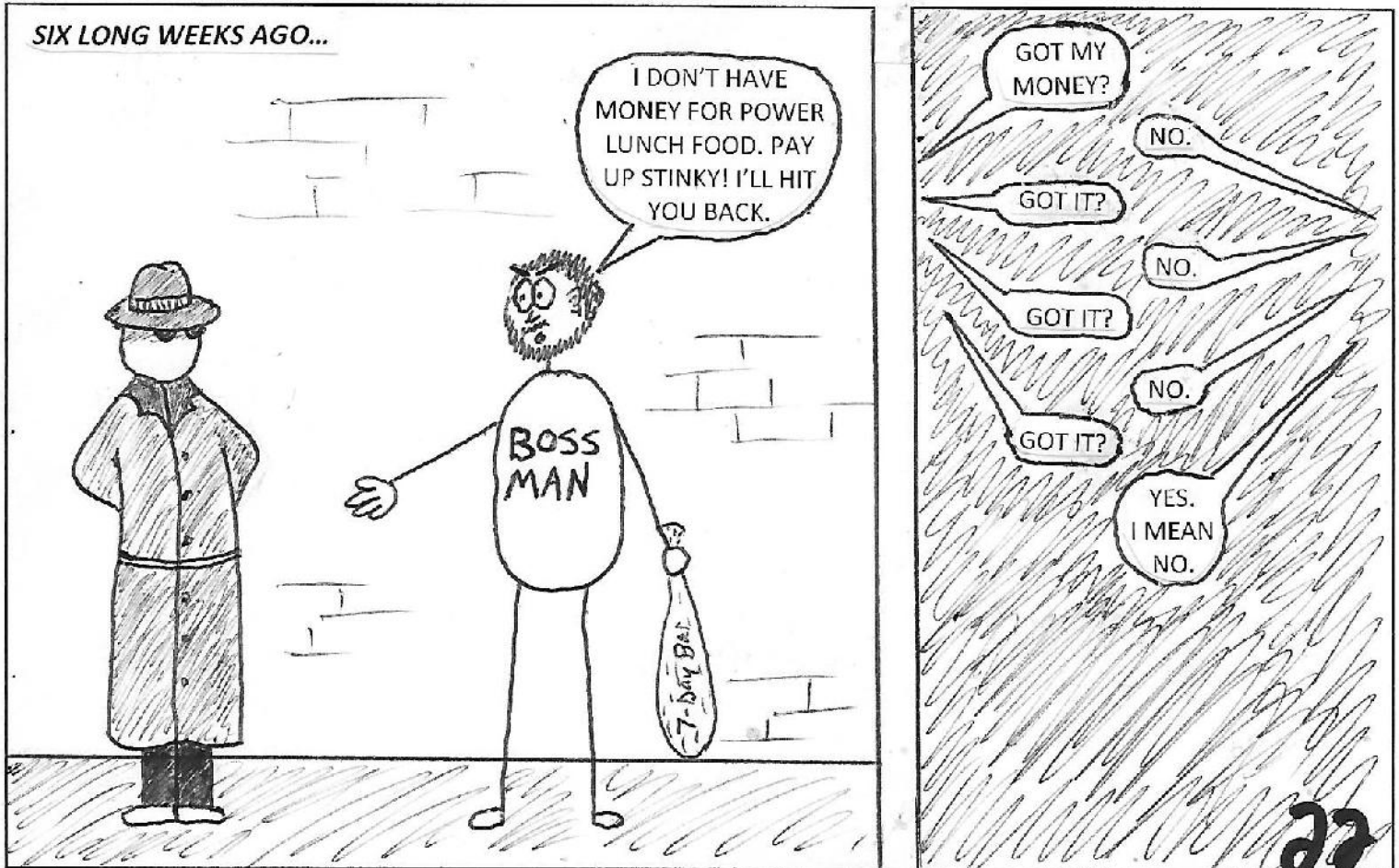
