Narrative:

(VB) Safeway has a grocery store located at 17202 Aurora AVE N in the city of Shoreline, county of King. (RP) Robert Campbell is a contract loss prevention agent for the above business.


Campbell was on duty in the above capacity on 03-11-14. At around 1045 hrs, he observed a male, later identified as (A) Perry Debell within the store. Campbell observed as Debell selected two bottles of vodka and concealed them in his left and right jacket pockets respectively. Debell selected two bottles of Sprite, but later set them down. Campbell maintained surveillance as Debell exited the store passing all points of sale. Debell did not remove the alcohol from his pockets and offered no payment for them.

Once outside of the store, Campbell stopped Debell and identified himself as store security. Debell was cooperative and returned to the store. Once inside, Campbell was able to recover the stolen alcohol valued at \$27.98 (pre-tax). Due to lack of physical identification on Debell's person, law enforcement was called to the scene. Deputy T. Morrell responded and was able to confirm Debell's identity via a King County Jail booking photo.

Debell was subsequently released from the scene.

Campbell completed a case report including surveillance video and sent it to the Shoreline Police Department for review under the Retail Theft Program.

On 05-20-14, I reviewed Campbell's documents and entered a copy of the surveillance video into evidence. I find that probable cause exists that (A) Perry Debell committed the crime of Theft Third Degree under RCW 9A.56.050. A copy of

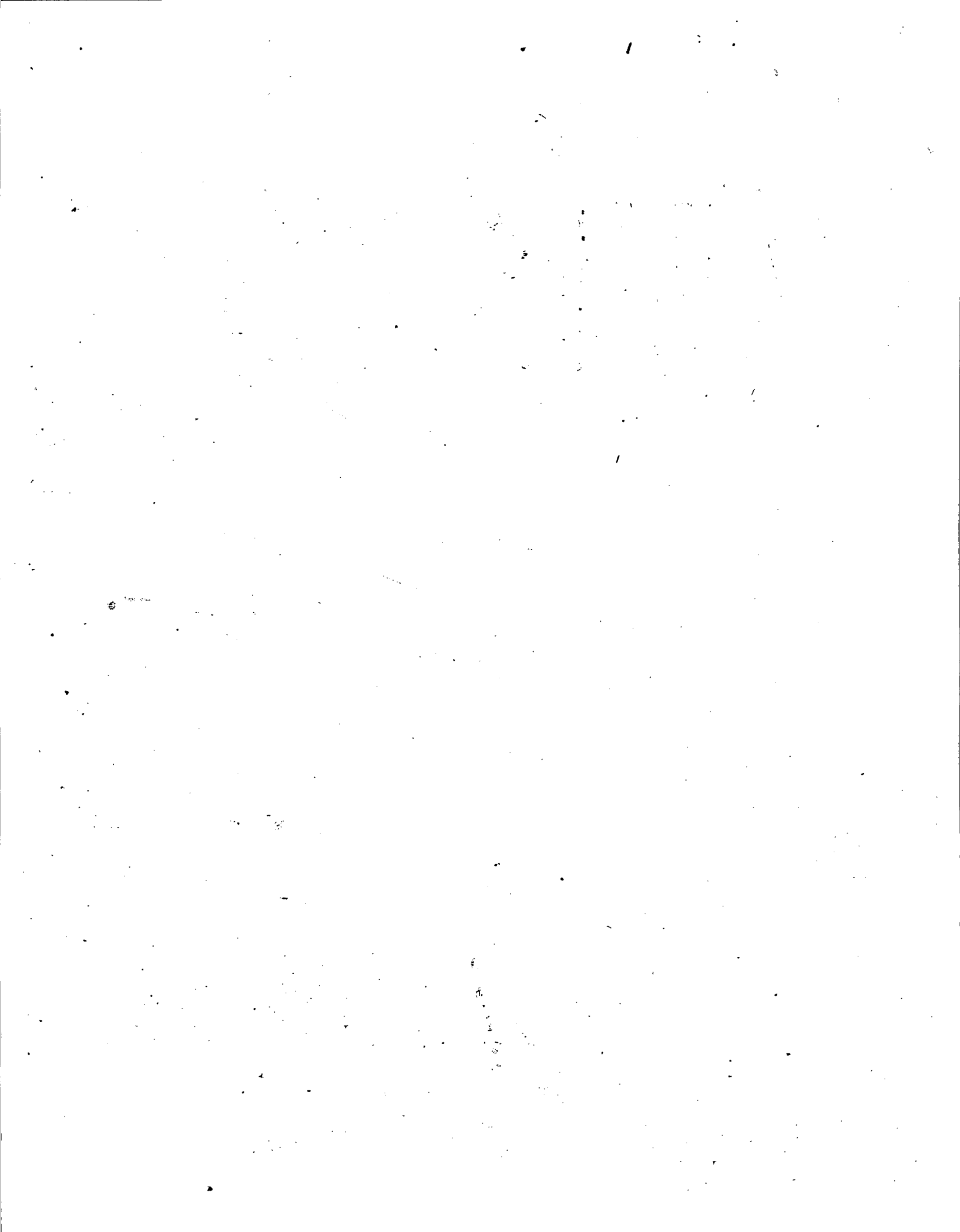

NARRATIVE:

While on duty at Safeway 0497 I LPA Raymond, Ross and LPA Robert, Campbell observed Debell, Perry enter the deli door and head towards the liquor aisle then selected two bottles of Smirnoff vodka, and concealed them, one in his left jacket pocket and another in his right jacket pocket. Debell then went on the next aisle and took two bottles of sprite and then walked behind the liquor aisle and went around to the check stand. Debell then put the two bottles of sprite down on the counter and proceeded to walk out the Deli door where he exited, bypassing all final points of sale without offering nor rendering any form of payment for the items concealed. Once outside, LPA Robert Campbell and I approached Debell identifying ourselves as store security and request that he returned back the merchandise and come back inside the store with us. Debell cooperated and came back into the LPA office for processing, he was unable to provide physical identification and Shoreline Dispatch was contacted. Shoreline PD responded and his identification was verified. Total amount of merchandise recovered \$27.98 minus all taxes. All merchandise was photograph and returned to store. NOTHING FURTHER TO REPORT.
