Bill,

Greetings. I'm a Highland Park resident who has been following the progress of the squatters camp known as Nickelsville. As you know, in late 2012, your department spent hundreds of person hours and tens of thousands of dollars of public money remediating a rat problem at the Nickelsville location in my neighborhood. That problem was caused by Nickelsville's failure to observe sanitary practices such as keeping food covered and keeping trash picked up in secure containers.

As you also know, Nickelsville was evicted from the Highland Park location in September of this year, costing the Health Department still more time and money. One of the new locations Nickelsville descended upon is in the Skyway section of unincorporated King County.

Unfortunately, Nickelsville was recently given a pass by Jim Chan (of the Department of Permitting and Environmental Review) to throw bags of trash in the corner at their Skyway squat and just leave them there until they can be picked up . . . whenever. (See the attached site visit report from Mr. Chan, wherein Mr. Chan equates a trash pile to a "dumpster." (!))

Not surprisingly, trash piles up frequently at Nickelsville Skyway, and it can only be a matter of time before rats once again appear in force. See my report, including several recent photographs, here:

Rats or no rats, the situation is a violation of health codes on the face of it and is precisely the same situation your department addressed with Nickelsville a year ago, when you compelled the camp's organizers to keep all their trash and food covered in rat-proof containers at all times.

You may consider this matter a citizen complaint and request for records.

First, I am asking you to make a site visit at Nickelsville's Skyway location and to compel them to follow the same sanitation rules there that you compelled them to follow at the Highland Park location.

Second, please provide me with an itemized list of services and equipment your department provided to Nickelsville Highland Park during the winter of 2012-2013. This would include anything from site visits, to trash cans, to hand washing stations, to pest control services. Please provide an itemized list of expenditures, a record of staff visits, and an estimation of the total amount of person hours spent by your department following the initial "rodent" complaint that came in to your office and sparked the investigation.

If you need to forward the request for records to another office, that's fine. But in any case, you'll have a heads up on the kind of information I'll be asking for.
